D.1. In September 2018, PPMH began a renovation of its OB unit; from the commencement of that renovation project through the end of 2018, PPMH operated 18 SUS OB beds. PPMH is maintaining its CON-authorized complement of 42 OB beds. Reported OB inpatient days include obstetric, labor and delivery, ante- and post-partum days.

D. 1/Psych/Substance Abuse Addendum A.1: PPMH's CON-authorized complement of adult inpatient psychiatric/substance abuse beds remains 38 beds. In 2018, PPMH had 18 of the 38 beds SUS.
